## **AGM Update**

We had 31 properties represented at the AGM, an encouraging level of support. The meeting endorsed the accounts and the various reports prepared by committee members, after discussion and clarification in some cases.

Lester Korzilius retired from the COM due to pressure of work and was thanked by the Chair for his year on the committee. Judith Morgan was elected to become a director and Martin Gebbett was re-elected. Lisa McGarry was confirmed as Independent Examiner of Accounts.

There were no resolutions submitted. Other business discussed included signage at the entrance to the estate and on the green. The former is now ready and we are considering whether any additional privacy notices would add anything. Sally Outram gave a valuable update on the discussions to date on the Coast Path being built by Natural England. Essentially, the current position is that the Planning Inspector came last June in response to the Outrams' objections and a final decision is awaited.

In my down time I like reading, the arts (especially Shakespeare), walking (particularly when I have my little dog) I row and attend the gym, mostly for yoga and Pilates but I do enjoy all types of training at the gym.

Rachel will be an excellent addition to our committee, and as previously advised, will be undertaking the following tasks:

- 1. Coordination of Council meetings, including production of agendas and compilation of reports.
- 2. Responding to emails, forward to relevant personnel. Sharing information with the Directors.
- 3. Maintaining secure cloud-based company archives including reports, minutes and correspondence.

### **Website**

I hope you have all had a chance to look at the webcam, now streaming live pictures from the front of the estate. Hopefully those less able to get out, especially in bad weather, or those that have moved away, will still be able to enjoy our fine harbour view. On 7th June, James Leeming (63) sets off on a huge cycling adventure and we will put a link to a live tracker on the website so that people can follow his progress. Hopefully we will also get some pictures along the way. This is what he is doing:

I will be cycling the Great Divide Mountain Bike Route (GDMBR), which is 2700 miles running from the Mexican border to Banff in Canada. I anticipate that it will take me approximately 2 months in June and July cycling approx. 65 miles per day with temperatures varying between 0 and 40°. It's an off-road route with climbing of over 7000m (the equivalent of seven times Mount Everest). I will be cycling solo but anticipate meeting people on route. I am self-supported so I will have my tent and cooker with me and anything else that I might need. Fingers crossed!

### **Gardens**

You will all have seen Andy working away and many of you will know how friendly and helpful he is - so I thought it would be good to get his take on the work he does. Here is what he had to say:

When I arrived for work on a beautiful still spring morning at the gardens last week I was struck by the large volume of bird song in the air. Unfortunately, I had to ruin this by employing the lawn maintenance machinery. I would like to apologise to the birds and residents alike for this disturbance. One day, all garden machinery will be electric and quiet.

The recent persistent wet weather has made it difficult to maintain the green areas especially the main green which retains a lot of moisture. I would like to ask residents to avoid using this area when the ground is sodden. As it further compounds the problem and makes the surface uneven and less pleasurable to use during the drier periods.

The beds look a little untidy at present as the spring flowering bulbs return to the soil; however, there are signs of strong growth coming through which will further show themselves in the weeks and months to come.



I am hoping that our summer this year is a more favourable one for the gardener than the last.

The gardens are still rather wet, though beginning to respond to the sunshine. After Andy complained about the damage done by footballers David Linington put round an email drawing attention to it, since when it has stopped. There were some complaints at the AGM about dogs on the lawn, but Andy says it has not been a problem, though the lawn alongside no. 46 and various lawns near the foreshore are still being fouled. We have replaced the ceanothus on the main lawn which had reached the end of its life. Andy will be getting on with planting, now the weather has improved. Everything should be looking good for the Big Lunch!

Lots of people's own gardens are also emerging well from the wet winter and starting to look great. There has been an evolution away from the original estate vision (from the architects) of essentially just having lawns and there are some lovely, and imaginative gardens.
